Dear Mr. Ahrendt:

This is in response to your letter dated June 20, 1979 in which you requested, pursuant to the Freedom of Information Act, copies of a summary sheet of power plant operator exam results presented to the Commission on April 20, 1979, and the actual nuclear plant operator license examinations and test results for any other Duke Power Company employees administered between January 1, 1975, and the present.

Enclosed, as listed in Appendix A, are documents subject to your request.

In a telephone conversation on July 16, 1979 with Ms. Ellen Whitlow of my staff, you agreed to bear the costs of reproducing these records. The charge for reproduction of records not located at the NRC Public Document Room is \$0.10 per page, as specified in 10 CFR 9.14(b). Accordingly, the cost of reproducing the enclosed 205 pages is \$20.50.
