I'm pleased to respond to the questions raised at our earlier meeting of April 26 and in Mr. Gorinson's letter of June 11, 1979 relating to the accident at Three Mile Island.

We have tried to provide thorough answers to your questions; however, the Commission has not reviewed the enclosures in detail and may have additional comments later, particularly with regard to Question V. Tabs A through F provide responses to those questions raised both at the April 26 meeting and in the June 11 letter. Tabs A through E respond to Questions I through V of the April 26 request, and Tab F answers Question I from the June 11 request. Please note that two of the three questions from the June 11 letter duplicate the April 26 request, and therefore are not reanswered. In addition, we are enclosing a copy of the scope of work between the firm Rogovin, Stern, and Hugo, Washington, D.C. and the Nuclear Regulatory Commission.
