Gentlemen:

We have completed our review of your revised Safeguards Contingency Plan which was transmitted to us by your letter of June 1, 1979, and find the revised plan acceptable.

In view of the fact that the Physical Security Plan and the Safeguards Contingency Plan comprise the essential elements of the physical protection program, we have found it appropriate to incorporate, by reference, both of these plans into your license. We are therefore revising License Condition 9.A.1 and establishing 9.A.1.A, referencing the Physical Security Plan and 9.A.1.B, referencing the Safeguards Contingency Plan. We are also modifying Condition 9.A.2 to refer to both of the foregoing plans. Accordingly, we are hereby amending Section 9.0 of Materials and Plant Protection Amendment MPP-1 to your License No. SNM-21 by revising License Condition 9.A.1 and 9.A.2 as set forth in the enclosure to this letter, effective 30 days after receipt.



ENCLOSURE

9.0 Physical Protection Requirements (Part A - DeSoto Avenue)

- 9.A.1 The licensee shall follow the plans indicated below:
- 9.A.1.A The licensee shall follow the security plan for the headquarters facility at DeSoto Avenue, A174-5, entitled "Security Program for the Physical Protection of Special Nuclear Material Possessed and Used by Atomics International Division of Rockwell International Under Special Nuclear Material License No. SNM-21," dated January 7, 1974; as amended February 25, 1974; July 19, 1974; October 25, 1974; January 31, 1975; April 7, 1975; April 18, 1975; April 9, 1976; and as amended pursuant to the provisions of 10 CFR 70.32(e).
- 9.A.1.B The licensee shall follow the plan entitled "Safeguards Contingency Plan for Rockwell International Energy Systems Group Headquarters Facility, ESG 78-24," dated September 15, 1978, as amended May 30, 1979, and as further amended pursuant to the provisions of 10 CFR 70.32(e).
- 9.A.2 No statement in the licensee's plans as described in 9.A.1 above shall relieve the licensee of any requirement of 10 CFR Part 73 unless granted in a specific exemption or exception set forth as condition to this license.
