This is in response to your letter dated May 31, 1979 in which you request, pursuant to the Freedom of Information Act, a copy of all documents pertaining to the importation into the United States, and disposal here, of nuclear waste materials from foreign countries.

Documents 3 through 5 were prepared by the National Security Council (NSC) and have been referred to the NSC for review, disposition and direct response to you.

A copy of the NRC Rules and Regulations covering the export and import of nuclear equipment and materials (10 CFR 110) and a DOE Policy Announcement regarding Spent Nuclear Fuel is enclosed.
