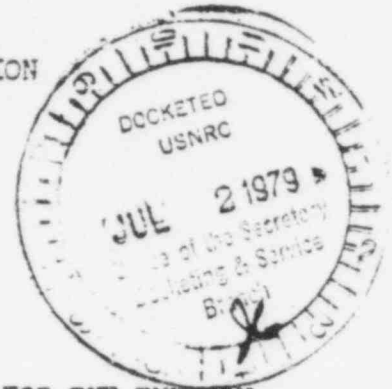

DEKALB AREA ALLIANCE FOR RESPONSIBLE ENERGY AND SINNISSIPPI ALLIANCE FOR THE ENVIRONMENT'S MOTION REQUESTING THAT THE BOARD POSTPONE SCHEDULING OF THE PREHEARING CONFERENCE UNTIL AT LEAST AUGUST 25, 1979

The DeKalb Area Alliance for Responsible Energy and the Sinnissippi Alliance for the Environment requests that the Atomic Safety and Licensing Board postpone scheduling of the prehearing conference until at least August 25, 1979 for the following reasons:

- 1) As of this date there has been no service of papers by the Commission upon all parties as directed by Section 2.712 of Title 10, Chapter 1, Part 2, Code of Federal Regulations.
- 2) Although the Board may have known earlier of the date planned for the Prehearing Conference, it was not until 25 June that we heard during a phone call from Mr. Richard Goddard, attorney-at-law, of the date of 25 July in Rockford, Illinois.
- 3) Documents essential to our petition, i.e. Byron Final Environmental Statement - 2 Vols.; Byron Final Safety Analysis Report, have been not yet placed as promised in the documents room of the Founders Library, Northern Illinois University, DeKalb, Illinois. Although these documents are located in the public library of Byron, Illinois - a small library, 35 to 40 miles distant, and open for limited hours of the day and days of the week - copies were to be conveniently placed for our use in the documents room of the local university.
- 4) The DeKalb Area Alliance for Responsible Energy and the Sinnissippi Alliance for the Environment together need at least a 30 day postponement of the July 25 Prehearing Conference in Rockford, Illinois in order to adequately prepare our amended contentions.
