"F.1.4 Interior pocket of kraft-fibre, in accordance with Drawing No. 2a, with 1/2" opening at top of pocket and slit on the right side to 4-1/4" from top opening; dimensions of the pocket shall be 7-1/2" L X 3-1/2" W for the back of pocket and 7" L X 3-1/2" W for the front of pocket; pocket shall be affixed inside front cover of folder and centered 1/4" from bottom of cover."

4. Under Section H, Subsection H.2 - Time of Delivery is deleted in its entirety and substituted with the following in lieu thereof:



- H.2.1 Delivery of the first Article of Item 1 is required by May 23, 1979."


5. This modification results in an increase in contract amount of \$1,050.00 from \$21,300.00 to \$22,350.00.


