
This refers to our meeting at the NRC Region II Office on July 11, 1979. The meeting related primarily to the licensed activities at Georgia Power Company's Hatch facility. An attendance list is enclosed.

The major subjects discussed during this meeting included the NRC Licensing process, the Inspection and Enforcement Inspection Program, and the Three Mile Island Accident. Specific matters relating to the Hatch facility included the Resident Inspection Program, emergency planning, tritium monitoring, concrete anchor repairs, Raychem cable, and statistical surveys. A tour of the Region II Emergency Response Center and the Fixed and Mobile Laboratories was also conducted.

Such meetings are considered to be extremely beneficial in that we were both able to openly discuss our activities and concerns. As agreed, we have enclosed a copy of "Population Dose and Health Impact of the Accident at the Three Mile Island Nuclear", dated May 10, 1979, and of NUREG-0396, "Planning Basis for the Development of State and Local Government Radiological Emergency Response Plans in Support of Light Water Nuclear Power Plants", dated December, 1978.
