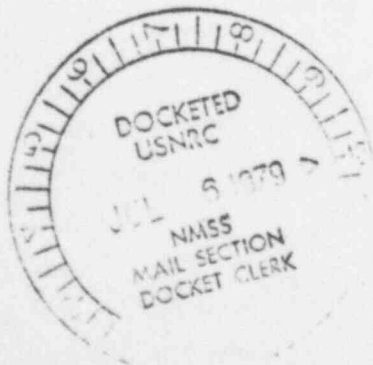

SHIPMENT OF IRRADIATED REACTOR FUEL

Dear Sir:

In accordance with the Code of Federal Regulation, Title 10, Part 73.72 and Part 73.37, Carolina Power & Light Company (CP&L) hereby provides written notification of its intention to continue shipment of irradiated reactor fuel from the H. B. Robinson Plant to the Brunswick Steam Electric Plant (BSEP) for storage in accordance with the attached planned schedule and the operating licenses for BSEP. A route description for these shipments is attached for approval. As can be seen from the description, the shipping route avoids any areas of high population density as described in NUREG-0561 "Physical Protection of Shipments of Irradiated Reactor Fuel".

As evidenced from the shipment schedule, CP&L will be shipping irradiated reactor fuel shortly after the implementation of the new 10 CFR 73.37 rule on Physical Protection becomes effective. Because of this, it is requested that the described route be approved and notification provided to CP&L by July 16, 1979.

It is CP&L's intention to fully meet the requirements of the new Part 73.37 rule. Our shipments after July 16, 1979, will be provided with an escort(s) with the required communications capabilities, written procedures will be in effect to cope with the required contingencies, and liason with the appropriate state law enforcement agencies will have been established. CP&L has chosen to set up liason with appropriate state law enforcement agencies who have jurisdiction over the proposed route because of the established communications networks that these agencies have with other local law enforcement agencies. CP&L does not desire assistance from the NRC in establishing arrangements with local law enforcement agencies.
