0 2 During Mode 1 operation, the L. P. Nitrogen Supply, Reactor Building Penetration, outside isolation valve, 2 CV-6213-2, would not close on Control Room demand signal. Penetration 2P41 was isolated immediately with the manual valve, meeting the requirements of Action Statement T.S.3.6.3.1c.
