GENERAL SAFETY INSTRUCTIONS FOR TRANSPORTATION AND USE OF RADIOACTIVE MATERIALS

- 1. RADIOPHARMACEUTICALS ARE OBTAINED BY THE NUCLEAR MEDICINE TECH AT THE UNIVERSITY OF MINNESOTA NUCLEAR PHARMACY.
- 2. THIS BOX SHOULD BE STAPPED TO THE SIDE AND FLOOR OF THE NUCLEAR VAN AND TRANSPORTED TO LAKEVIEW HOSPITAL IN STILLWATER, MINNESOTA.
- 3. BEFORE OPENING, THIS BOX SHOULD BE MONITORED WITH A G-M COUNTER FOR LEAKS OR CONTAMINATION. RECORD RESULTS.
- 4. OPEN THE BOX AND TAKE OUT THE SHIELDED VIALS AND DOSES.
- 5. USING THE DOSE CALIBRATOR, DRAW UP PRECALIBRATED DOSES FOR THE DAY AND PLACE THEM IN LEAD LINED BOX.
- 6. MONITOR EMPTY BOX FROM THE NUCLEAR PHARMACY FOR CONTAMINATION. RECORD RESULTS.
- 7. TRANSPORT PRECALIBRATED DOSES IN LEAD LINED BOX BY STRAPPING IT TO THE SIDE AND FLOOR OF THE NUCLEAR VAN.
- 8. WASTE AND USED SYRINGES SHOULD BE KEPT IN A SECOND LEAD LINED ISOTOPE BOX WHICH IS ALSO STRAPPED TO THE SIDE AND FLOOR OF THE NUCLEAR VAN.
- 9. RETURN WASTE AND SYRINGES TO THE NUCLEAR PHARMACY FOR DISPOSAL.
- 10. EACH DAY A SURVEY OF THE NUCLEAR VAN SHOULD BE DONE WITH A G-M COUNTER. RECORD READINGS ON FORM PROVIDED (LOCATED ON WALL IN VAN).
