This refers to the inspection conducted by Dr. J. Glenn and Mr. R. McClintock of this office on May 22, 1979 at your Port Norris, New Jersey facility of activities authorized by NRC License No. 17-16109-01 and to the discussions of our findings held by Dr. Glenn and Mr. McClintock with Dr. Parker and Mr. Richard of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the Office of Inspection and Enforcement Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, measurements made by the inspector, and observations by the inspector.

Within the scope of the inspection, no items of noncompliance were observed.

In accordance with Section 2,790 of the NRC's "Rules of Practice" Part 2, Title 10, Code of Federal Regulations, a copy of this letter and the enclosed inspection report will be placed in the NRC's Public Document Room. If this report contains any information that you (or your contractor) believe to be proprietary, it is necessary that you make a written application with n 20 days to this office to withhold such information from public disclosure. Any such application must be accompanied by an affidavit executed by the owner of the information, which identified the document or part sought to be withheld, and which contains a statement of reasons which addresses with specificity the items which will be considered by the Commission as listed in subparagraph (b)(4) of Section 2.790. The information sought to be withheld shall be incorporated as far as possible into a separate part of the affidavit. If we do not hear from you in this regard within the specified period, the report will be placed in the Public Document Room.

From the discussions of our findings at the conclusion of the inspection, it is our understanding that you will make a new survey of your restricted areas to verify the results of your previous surveys and to determine if any changes

In addition, we understand that you will look for the records of burials performed under terminated License No. 29-12346-01 and will make those records available for review during the next inspection of your licensed program. Furthermore, we understand that you plan to provide an additional tamper-proof lock for your hot cell entrance.
