NOTICE OF TAKING DEPOSITIONS

TO ALL PARTIES AND THEIR RESPECTIVE COUNSEL, TO THE DEPONENTS IDENTIFIED BELOW, AND TO MARSHALL E. MILLER, CHAIRMAN, ATOMIC SAFETY AND LICENSING BOARD:

Applicant Pacific Gas and Electric Company (hereinafter "PGandE") will take the depositions of the individuals identified below at the times and places indicated for each, or at such other place as may be mutually agreed to by the parties and the respective witnesses. Each deponent will be examined with respect to:

- (a) Past and present operations, practices and policies of the electrical system operated by the entity with which the deponent is affiliated;
- (b) The deponent's knowledge of any allegedly restrictive or other unlawful practice or policy of PGandE and the effects, if any, on the electrical system operated by the entity with which the deponent is affiliated or any other electrical system;
- (c) Policies with respect to future expansion of the electrical system operated by the entity with which the deponent

is affiliated and planned changes to the operating practices discussed under (a), above;

- (d) Agreements or understandings regarding any aspect of electric power generation or distribution between the entity with which the deponent is affiliated and any other entity, including agreements or understandings with the Northern California Power Agency (hereinafter "NCPA") or other members of NCPA;
- (e) Communications relating to electric generation or distribution between persons representing the entity with which the deponer is affiliated and any other entity;
- (f) Lobbying efforts relating to electric generation or distribution conducted by the deponent or by other persons acting on behalf of the entity with which the deponent is affiliated.

Each deposition will be taken before a notary public to be selected by counsel for PGandE, whose identity(ies) will be communicated at a later time.
