Dear Mr. Ippolito:

This is in response to your letter of August 20, 1979, which we received on August 24, 1979, requesting us to review the list of amendment requests filed by Philadelphia Electric Company currently pending before the Commission. You requested that we advise you if any of the items listed were no longer required, and for those items still required you requested that we assign a priority as to their importance to the Licensee.

The list which was enclosed with your letter contained six items pending before the Commission. Since receipt of your letter, the Commission has issued license amendments relating to two of these items (heavy metal sampling; suspended solids and pH). The list enclosed in this letter assigns a priority to the remaining four items. Additionally, the enclosed list adds amendment requests filed subsequent to the latest item listed in the attachment to your letter and assigns a priority to these additional items.


