RESEARCH TO BE PERFORMED BY CONTRACTOR Article A-I

- (a) The unclassified scope of work under this contract entitled, "A Study of New England Seismicity with Emphasis on Masschusetts and New Hampshire" shall be as follows:
 - To continue the operation of the M.I.T. Seismic Network and significantly upgrade the quality of the data. This will 1) include the replacement of all telemetry components and the inclusion of automatic calibration units at each site. Some of the data will be recorded digitally on the HP-1000 computer. Install a seismic station in a deep borehole on Nantucket lsland.
 - To determine the crust and upper mantle structure from seismic refraction experiments, teleseismic P-wave residual inversion, 2) and surface wave dispersion analysis. This will improve the computation of local earthquake hypocenters.
 - To determine fault plane solutions for local earthquakes and 3) thus determine the state of stress within the crust.
 - To determine an earthquake magnitude scale for New England 4) based on total signal duration.
 - To estimate local variations of strong ground metion using the 5) data from small earthquakes.
