SUBJECT: ALLEGED INTIMIDATION OF CIVIL QC INSPECTORS AT THE  
SOUTH TEXAS PROJECT, UNITS 1 & 2

On November 2, 1979, two Brown & Root (B&R) QC inspectors contacted the NRC Resident Reactor Inspector (RRI) to report alleged threats and intimidation directed at five B&R Civil QC inspectors by B&R construction personnel. One QC inspector, acting as the spokesman, stated that most of the alleged threats were made during the course of concrete placement activities including meetings, preplacement and placement inspections. The spokesman identified four QC inspectors in addition to himself, who are willing to provide statements to the NRC regarding the threats and intimidation. The QC inspector who accompanied the spokesman declined to reveal his identity. The spokesman named two construction personnel involved in the alleged intimidation.

The Region IV office plans to conduct an investigation of the allegations.

This information is current as of 9:00 a.m. on November 6, 1979.

No press release is planned by Region IV.
