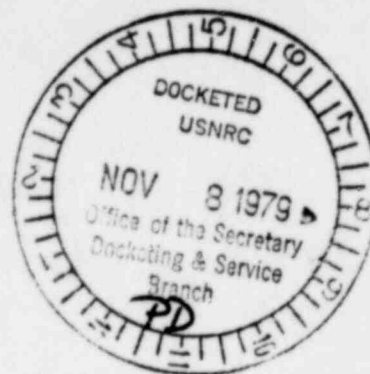

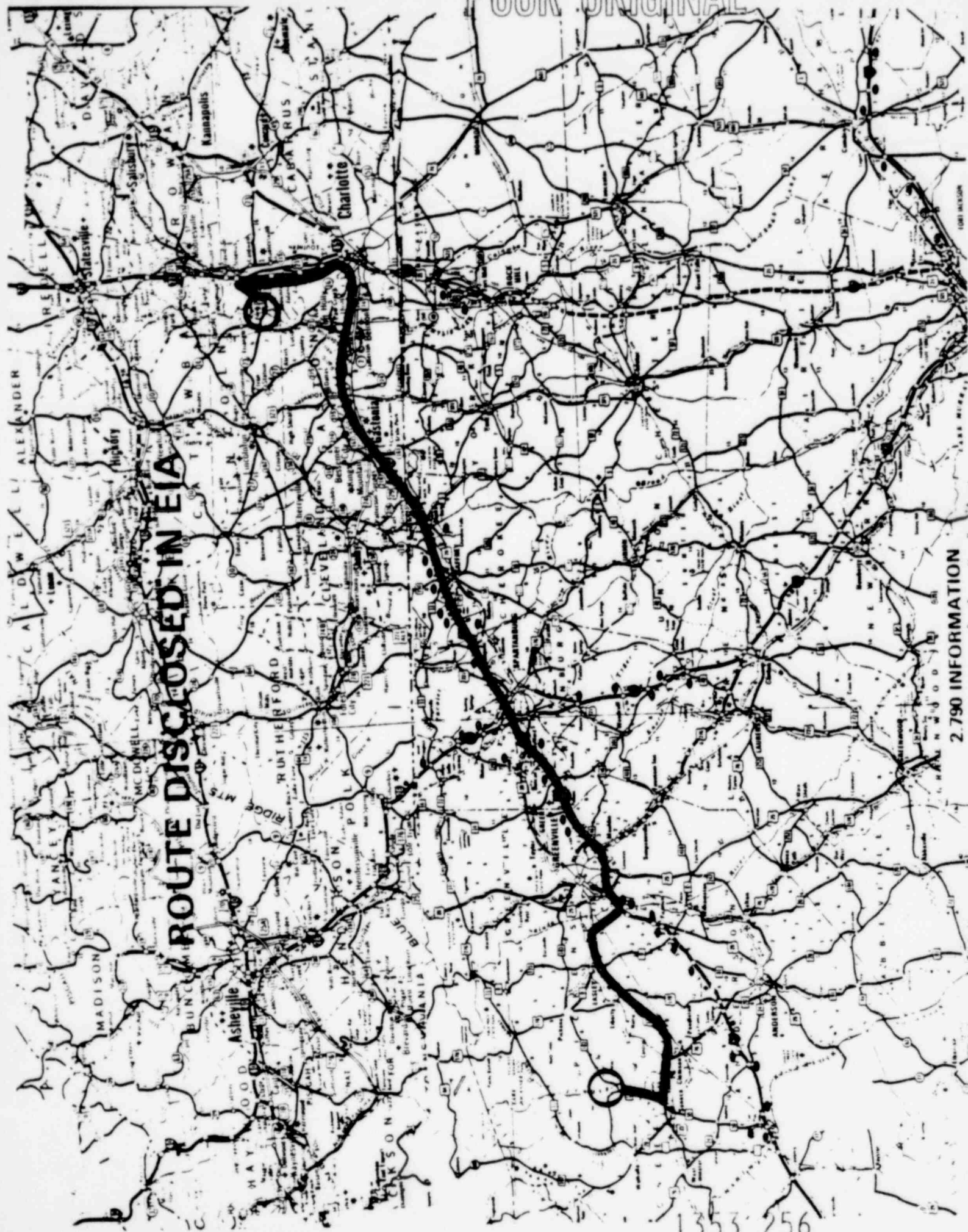

ROUTE DISCLOSED IN EIA

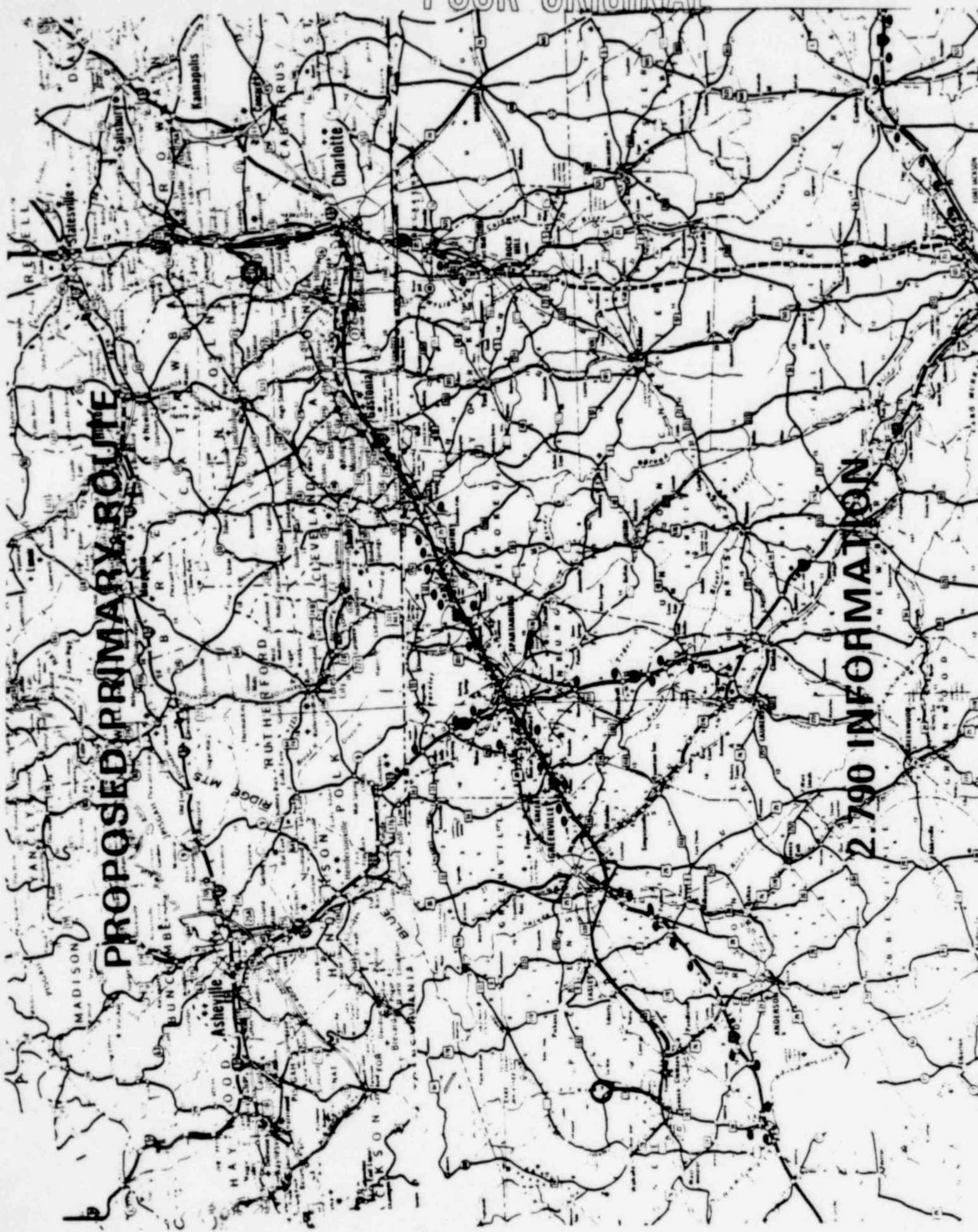

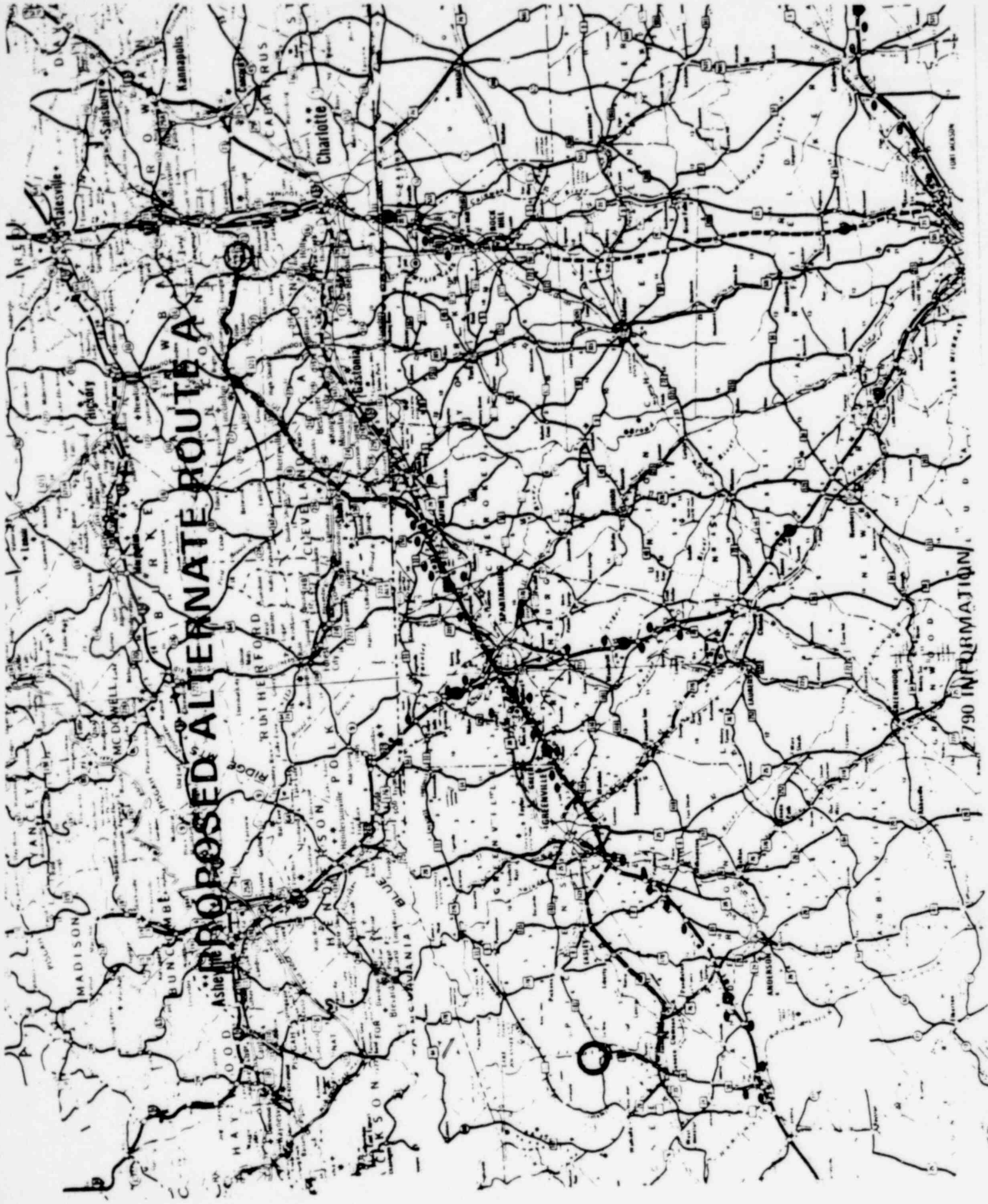

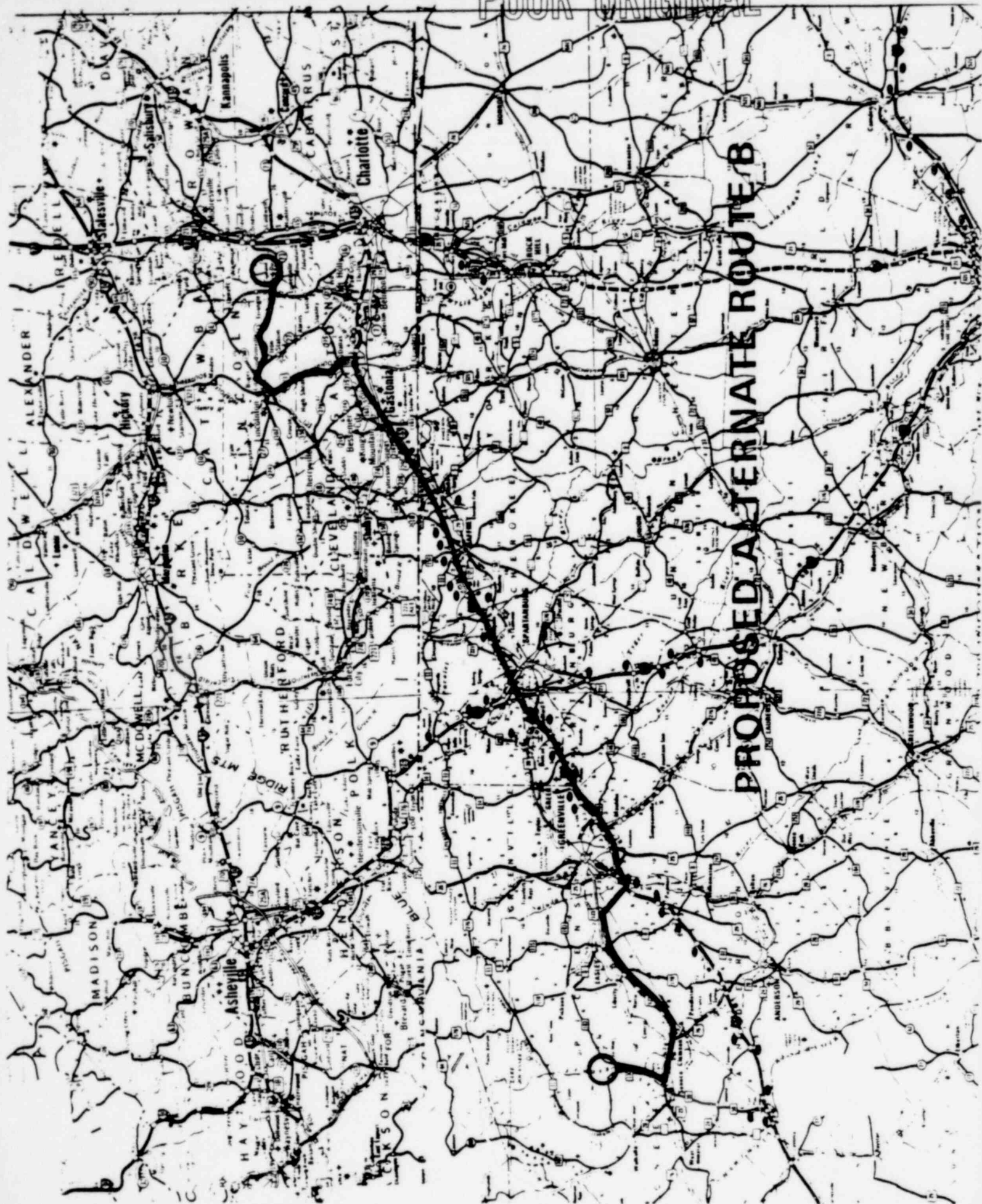




PROPOSED ALTERNATE ROUTE A

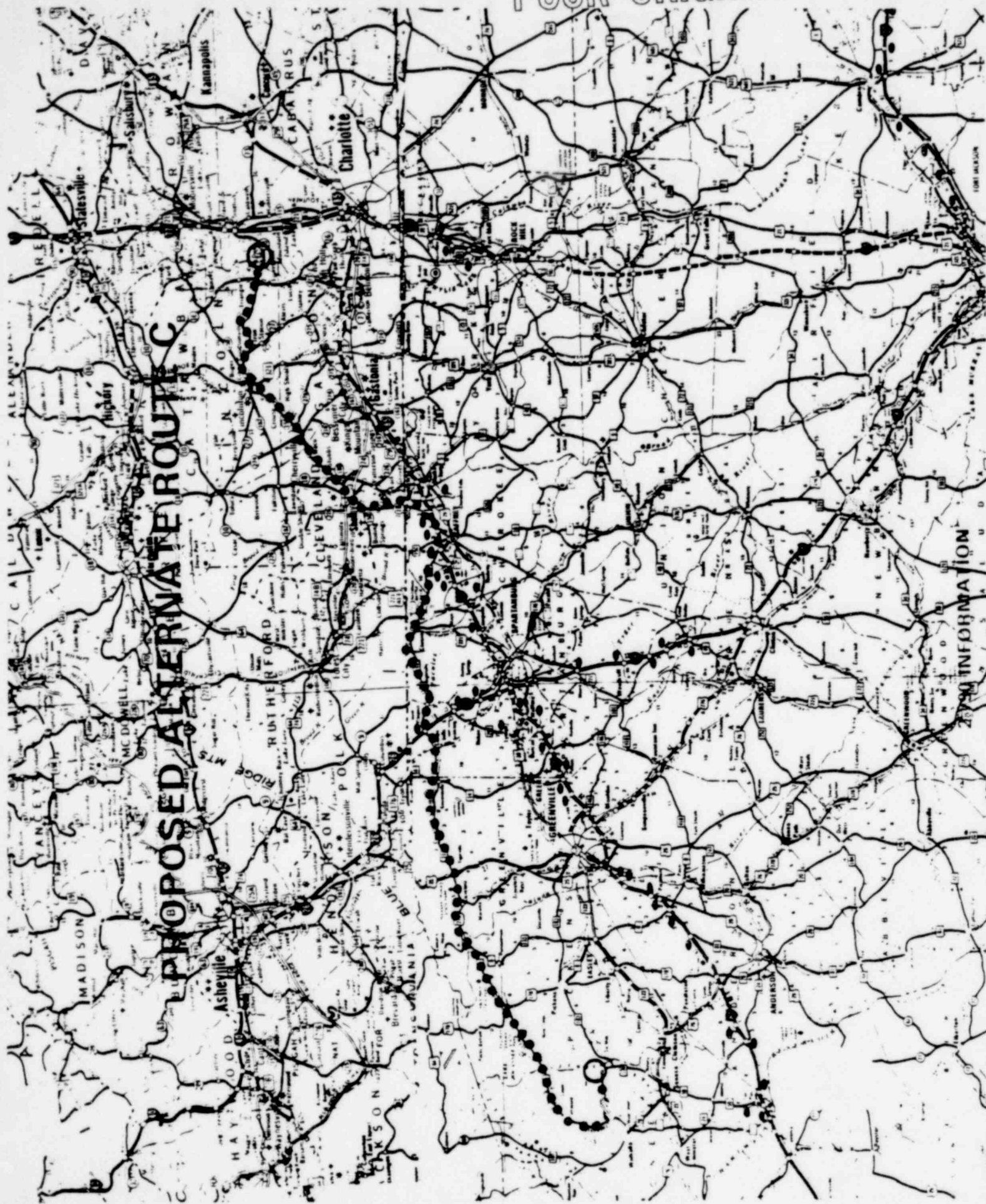

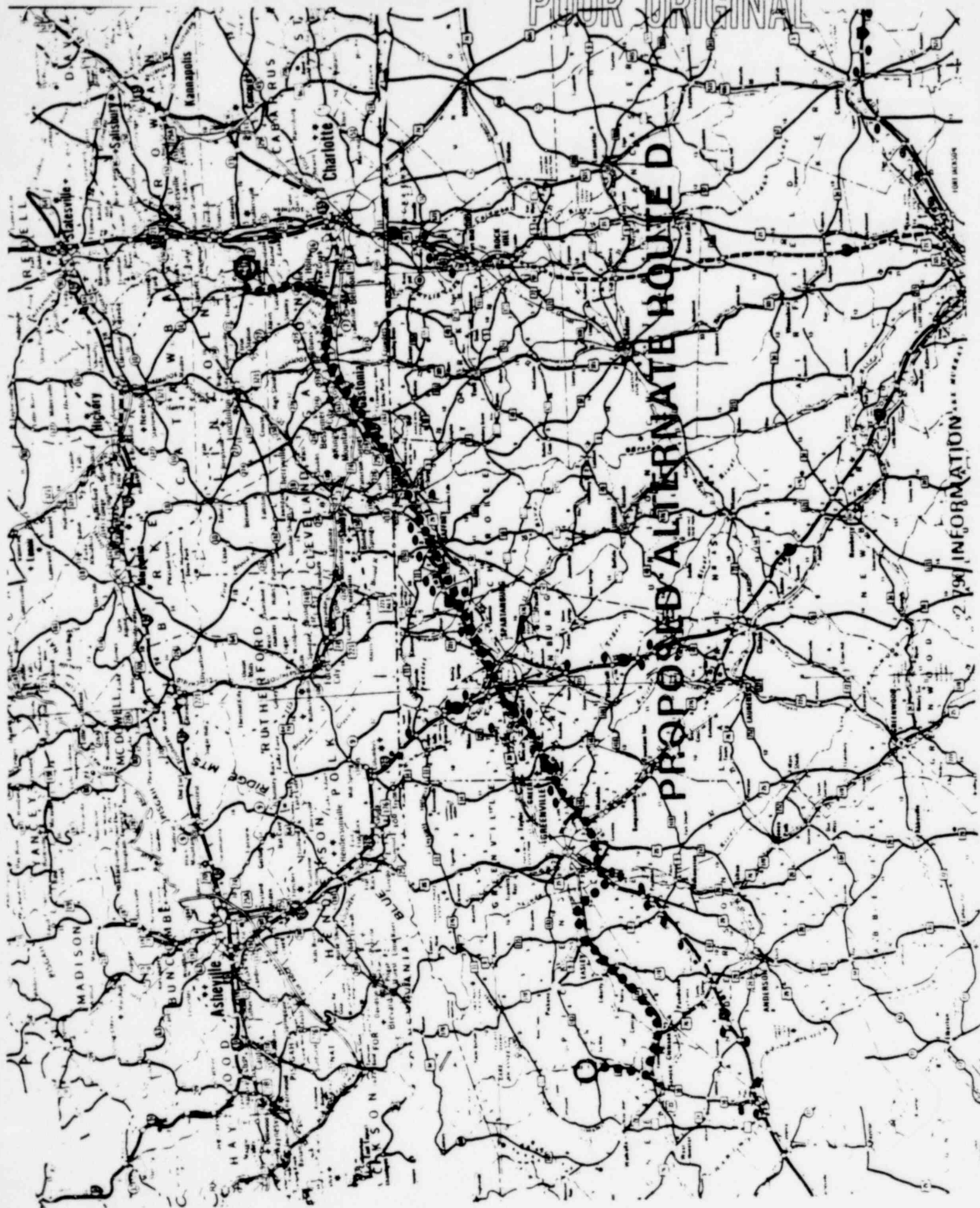


PROPOSED ALTERNATE ROUTE B

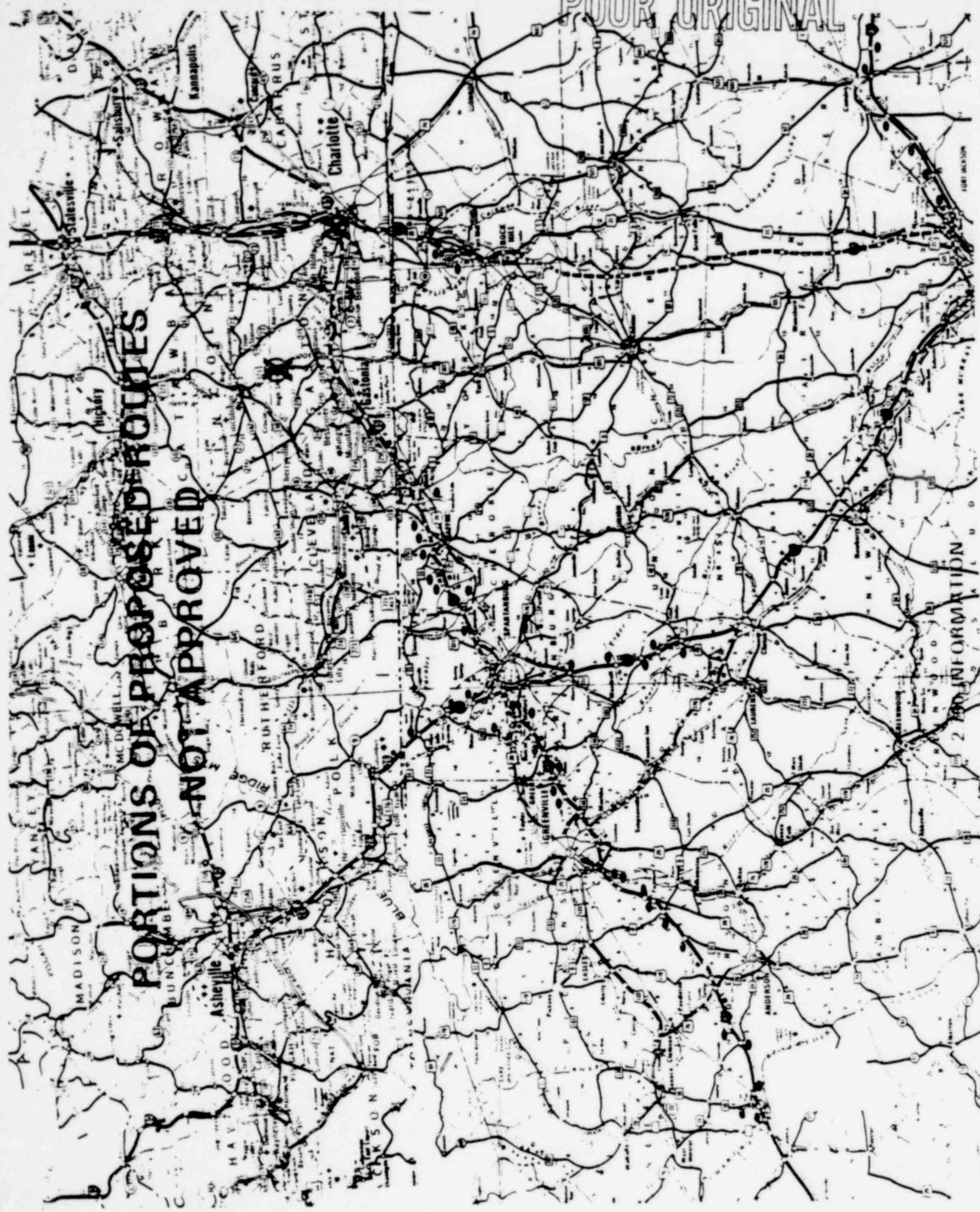

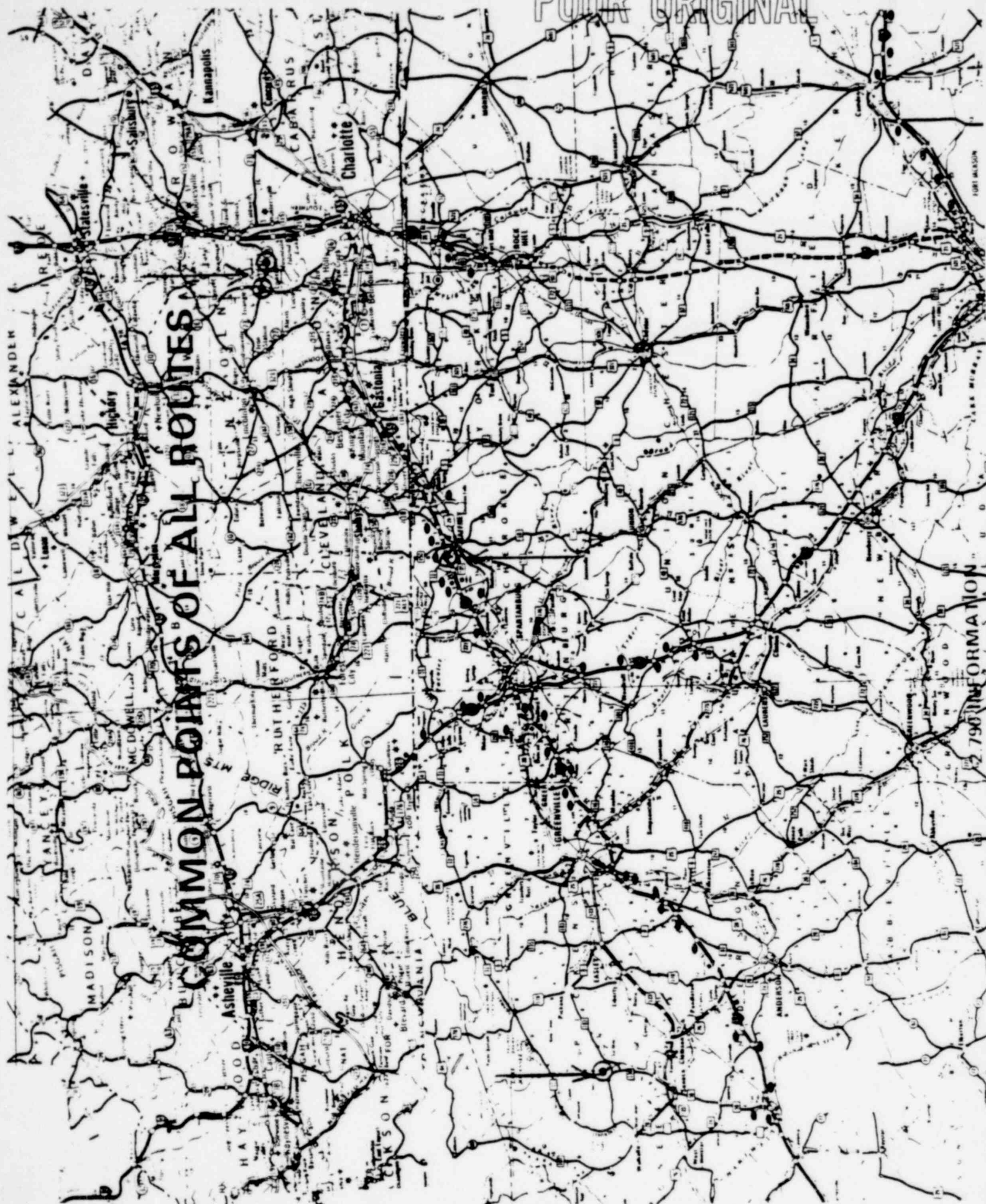
