Dear Ms. Janda,

Thank you for reviewing the report from Ms. Katanic's visit to the Alliance mobile unit in Idaho. In response to the notice of violation, I submit the following:

A. The technologist did not perform the incoming radioactive package receipt according to Alliance policy. A required wipe test for removable contamination was not completed. Alliance maintains the steps to properly receive radioactive packages posted on the wall in the hot lab to include the exterior wipe of each package. The Technologist did not perform this step in receiving the package.

Subsequently, Alliance performed a root cause investigation and has instituted corrective actions with this Technologist and the entire Northwest Team. The correct package receipt procedure has been reviewed with the Team and Alliance has confirmed the posting outlining the procedure is posted in the hot lab where packages are received on all mobile units.

B. The Alliance policy NM RS 0015-Ordering and Receiving Radioactive Materials has been updated to reflect the requirement to perform an external wipe of the package before the package is opened. The policy contained this language previously, but did not state that the wipe was required before opening the package. The policy has been amended to reflect the proper order of surveying and checking for removable contamination before opening the package.

Alliance appreciates this opportunity to improve our Radiation Safety Program. At this time, Alliance is in full compliance.
