Millstone Nuclear Power Station, Unit No. 2
Licensing Fees

In Reference (1), Northeast Nuclear Energy Company (NNECO) proposed revisions to Technical Specifications concerning inservice inspection (ISI) and testing programs. Subsequently, the NRC Staff advised that: (1) modifications to the proposed wording would be required, and (2) the Staff did not concur with the stated fee determination.

Because it was understood that a supplement to Reference (1) was forthcoming no later than January 26, 1979, NNECO advised that a Class III fee payment would accompany that supplement to resolve the fee issue. This second submittal will address the details of the ISI program and request specific exemptions to 10CFR50.55a.

However, in direct response to Reference (2), enclosed is payment in the amount of four thousand dollars (\$4,000). Because review of a single safety issue is required, NNECO has determined that the enclosed fee is applicable to Reference (1), the submittal scheduled for January 26, 1979, and any other supplements which the Staff may require on this subject.

We trust the above information is responsive to your request.
