Gentlemen:

This refers to the discussion between yourself and other members of your organization and Mr. Fiorelli and others of this office on May 11, 1979, regarding construction practices at Wm. H. Zimmer Nuclear Power Station, Unit 1. With regard to certain construction practices discussed, we understand that you will discontinue construction on the suppression pool modification adding the safety relief valve quencher discharge devices and not resume activities until the following actions of this Immediate Action Letter have been fulfilled.

1. Cincinnati Gas and Electric Company will conduct a comprehensive audit in accordance with 10 CFR 50, Appendix B and ASME Section III, NA 4000, to establish the status of conformance with required codes, specifications and procedures. This audit activity will include review of procedures and records which may already be in use.
 2. Where the audit determines that work already completed does not conform to required codes, specifications and procedures, action will be taken to correct the deficiencies and preclude their recurrence. The corrective actions will include the items identified by our inspector during an inspection conducted the week of May 7, 1979. This audit and the corrective actions will be documented so that they can be readily reviewed.
 3. This office will be notified periodically of the progress of your effort so our inspector can observe and evaluate the effectiveness of your review and corrective actions.





Stop Work Order #79-05, covering all construction activities related to the MSR/V modifications in the Suppression Pool, is hereby conditionally reinstated, as defined by the below paragraph.

The NRC inspection conducted from 5-8 to 5-11-79, identified various deficiencies which were the basis for the stop work order issue. Corrective action was implemented and verified by the NRC on 5-17 and 5-18-79.

Work activities may proceed in the suppression pool in those areas that do not have outstanding NR's or procedural deficiencies. Work may not continue on those items that have identified deficiencies until the time that such deficiencies are resolved in accordance with project procedures.
