

EVENT DESCRIPTION AND PROBABLE CONSEQUENCES (10)

At 2148 CST 2-14-79 while performing startup test procedure HNP-2-10925, MSIV closure, it was noted from the test data that 2B21-F028A, outboard MSIV, closed in 2.0 seconds. This violated tech specs section 6.9.1.9.b by not closing within the tech spec setpoint of 3 sec. less than or equal to t less than or equal to 5 seconds. This is a non-repetitive occurrence.

CAUSE DESCRIPTION AND CORRECTIVE ACTIONS (27)

The cause of the fast closure time was found to be the failure of the seal cartridge bushing and seal assembly, and rod packing on the Rockwell Manufacturing Co. cylinder with actuator 24" x 20" x 24" size, figure no. 1612 JMMNTY. The MSIV had its damaged parts repaired per procedure HNP-2-6280 MSIV maintenance and functionally tested per MSIV calibration procedure HNP-2-3111 before being returned to service.
