Dear Dr. Hagedorn:

By letter dated July 18, 2019, DeKalb Memorial Hospital, Inc. submitted to the U.S. Nuclear Regulatory Commission (NRC) a request for consent to indirect license transfer of NRC Materials License No. 13-18506-01 pursuant to a member substitution agreement with Parkview Health System, Inc. The letter is available electronically from the NRC's Agencywide Documents Access and Management System (ADAMS) at Accession Nos. ML19200A268 and ML19219A340. Based on the information provided, Parkview Health System, Inc. will become the sole corporate member of DeKalb Memorial Hospital, Inc. Further, we understand that this transfer will not result in any change to the licensed materials, persons using the licensed material, locations of use of licensed material, or persons responsible for the licensee's radiation safety program.


Based on the above understandings and as more fully detailed in the enclosed NRC staff's Safety Evaluation Report which documents the NRC staff's review of the request, we have no objection to the proposed transfer. Please note that you will need to notify us promptly, in writing, after the transaction has been finalized and include a signed copy of the agreement confirming completion of the transaction. With this information, we can issue an amendment to your NRC license to reflect the transaction. If this planned sale has not been consummated within 30 days of the date of this letter, please notify us in writing.

The NRC's Safety Culture Policy Statement became effective in June 2011.
