By letter dated July 8, 1977, Metropolitan Edison Company requested deletion of certain non-radiological environmental technical specification requirements for Three Mile Island Nuclear Station Unit 1. This is a request for technical assistance from the Environmental Specialists Branch and the Hydrology-Meteorology Branch to review certain data presented by the licensee in their annual reports for 1974, 1975 and 1976 to determine whether the specification requirements have been satisfied and the specifications can be deleted. DSE should be the best qualified to perform these reviews as the licensing action on Unit 2 is nearing completion. We request that ESB evaluate Specifications 4.1.2.1 "Bird Impaction on Cooling Towers;" 4.1.2.2 "Effect of Cooling Tower Salt Drift on Crops and Natural Vegetation;" and 4.1 "Chemical" Monitoring, and that NMH evaluate Specification 4.3 "Thermal Plume Mapping." We request that the data collected under these specifications be examined and compared to the specifications to determine if the requirements have been met. We further request that staff analyses implied by the ETS objectives, specifications, and bases, be performed. We request this review be completed by February 15, 1978 and the response transmitted to the Assistant Director for Operational Technology.
