On December 28, 1978, the Southern California Edison Company (Edison), not a party to this proceeding, appeared specially and filed a motion to quash a subpoena duces tecum which had been served upon Edison by DMR. This motion was supported by points and authorities and the affidavit of Lowell John Dosch.

The Board will consider the following matters, among others, at this resumed prehearing conference:

- DWR motion of September 14, 1978 regarding discovery and scheduling, as modified by DWR motions dated December 1, 1978.
- Prehearing conference briefs filed by all parties December 1978, and January 1979.
- Issues related to the Stanislaus Commitments, Mendocino Advice Letter of Attorney General, Stanislaus Advice Letter and correspondence from Attorney General, Mooted Issues, if any, Pending Hearings in Other Fora.
- Reports on status of discovery, including document production and analysis of information derived or anticipated from such discovery.
- Consideration of suggestions to expedite discovery and schedule evidentiary hearings.
- 6. Consideration of other pending motions or requests.
