This refers to your license amendment request dated August 16, 2019. Please find enclosed Amendment No.58 removing Dr. Richard T. Mull as an authorized user and releasing Room 1-40 for unrestricted use. We are not able to process your request for termination at this time as we have not received a request for amendment of the Defense Health Agency's (DHA) license to add your facility. This action will be performed once the request from the DHA is received.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking Your License as specified in the NRC Enforcement Policy.
