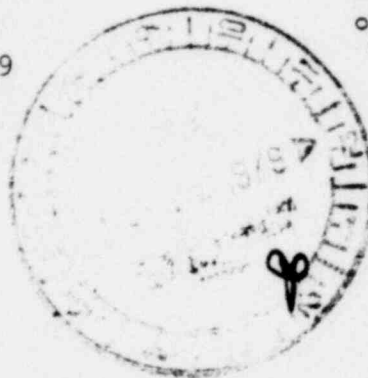



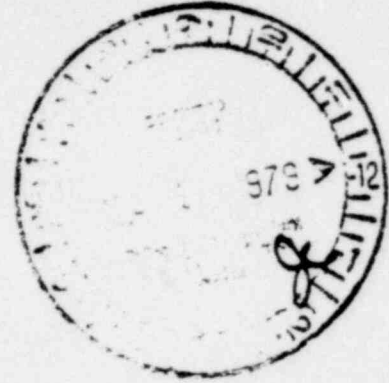
directly to the parties. However, I would still appreciate
