DESCRIPTION OF AMENDMENT/MODIFICATION
 The purpose of this modification is to exercise the option to extend the contract for another year in accordance with Article II, Section B of Modification # 1 and to provide additional funding in the amount of \$20,000.00 to cover the period of performance.

CHANGE
 I. Under Article II, Section A of Modification # 1, add the following;
 "The period of performance for third year's effort shall begin on September 1, 1979 and end on August 31, 1980."
 II. Under Article IV of the original Contract, delete Paragraphs (a) and (b) in their entirety and insert the following in lieu thereof;
 " (a) CONSIDERATION- The COMMISSION agrees to pay the STATE a fixed sum of \$42,500.00 accordingly, \$7,500.00 for the first year's effort, \$15,000.00 for the second year's effort, and \$20,000.00 for the third year's effort. It is understood by all parties that DOT will not perform any services except as provided in Article III nor pay any monies to the STATE. "

Except as provided herein, all terms and conditions of the document referenced in block 8, as heretofore changed, remain unchanged and in full force and effect.
