SUBJECT: RESPONSE TO NRC INSPECTION 030-38858/2019-001 AND NOTICE OF VIOLATION

Dear Mr. Ringsak:

On August 23, 2019, the U.S. Nuclear Regulatory Commission (NRC) cited Madison Engineering, LLC, for two violations that involved failures to: (1) perform contamination leak tests every 6 months and (2) ensure hazmat employees receive recurrent hazmat training every 3 years. The NRC Inspection Report 030-38858/2019-001 with enclosed Notice of Violation (Notice) required you to reply in writing in 30 days (NRC Agencywide Documents Access and Management System (ADAMS) Accession ML19241A173). In a letter dated September 5, 2019, you provided your reply to the Notice (ADAMS Accession ML19274B710).

After reviewing the information provided in your reply to the Notice, we have concluded that your completed and proposed actions appear to adequately address the regulatory noncompliance described in the Notice. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained.
