Hi Alex,

Section IV page 6 of Order EA 06-203 is directed to "Licensees and any other person adversely affected by this Order..." giving them an opportunity to request a hearing if they find that the Order adversely impacts them. If Oklo, feels that it is adversely affected it could respond to the Order as stated. If not, then there is no requirement to request a hearing within 20 days.

The Order was addressed to, "Holders of Licenses and All Other Persons Who Seek Access to Safeguards Information as Specified in the Enclosed Order." Oklo falls into the category of "all other persons," and is seeking access to SGI Regulatory Guides, therefore Oklo is subject to the provisions in the Order. Further, the Order imposes the requirement for a reviewing official which does not appear in 10 CFR 73.21 or 10 CFR 73.22.

Finally, NRC is requesting acknowledgment that Oklo agrees that the Order is applicable, and agrees to comply with the Order. Once I receive this, I can arrange to send the SGI regulatory guides to you.
