This refers to the inspection conducted by Dr. Bores of this office on December 7, 1978 at Peach Bottom Atomic Power Station, Units 2 and 3, Delta, Pennsylvania, of activities authorized by NRC License Nos. DPR-44 and DPR-56 and to the discussions of our findings held by Dr. Bores with Mr. Ullrich and Mr. Scholz of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the Office of Inspection and Enforcement Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.


Within the scope of this inspection, no items of noncompliance were observed.

If we do not hear from you in this regard within the specified period, the report will be placed in the Public Document Room.
