NOTIFICATION OF TRANSFER OF CONTROL, MAIL CONTROL NO. 611797

Dear Dr. Wachsstock:

By the letters dated December 20, 2018 (Agency Documents Access and Management System (ADAMS) accession number ML19093B747) and April 18, 2019 (ML19119A290), Radiocat, LLC submitted to the U.S. Nuclear Regulatory Commission (NRC) requests to correct the name on their license and for written consent to an indirect license transfer of NRC Materials License No. 45-25330-01. Based on the information provided, the NRC understands that Radiocat, LLC, will be indirectly transferred to RadioCat Holding, LLC, which will be a joint venture between the original owners of Radiocat, LLC, (David Herring, DVM, ACVR and Rand Wachsstock, DVM), who will become minority owners, and PetVet RadioCat, LLC, which will become the majority owner of RadioCat Holding, LLC. We further understand that this transfer will not result in any changes to the licensee name, location of use, materials, persons using licensed material, or persons responsible for radiation safety at the licensed facility.

As more fully detailed in the enclosed Safety Evaluation Report, which documents the NRC staff's review of the request, and in accordance with 10 CFR 30.34, the NRC consents to the proposed transfer. Please note that you will need to notify us promptly, in writing, after the transaction has been finalized and include a signed copy of the sale agreement confirming completion of the transaction. With this information, we will issue an administrative amendment to your NRC license to reflect the transaction. Please notify the NRC in writing, if this planned sale has not been consummated within 30 days of the date of this letter, or this consent may be deemed null and void.

Future changes in the licensee's name, licensed use, licensed materials, licensed location, or persons responsible for licensed material require submission of a request to amend the license. NRC approval must be received prior to implementation of these types of changes. Such changes were not proposed in the present request for consent.

Please find enclosed administrative Amendment No. 31, which reflects the correct licensee name Radiocat, LLC, which was verified during a pre-licensing inspection on September 17, 2019.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14). In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be available electronically for public inspection in the NRC Public Document Room or from the NRC's document system (ADAMS). ADAMS is accessible from the NRC Web Site at: <http://www.nrc.gov/reading-rm/adams.html>.

This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking Your License as specified in the NRC Enforcement Policy.
