Summary

If one includes caterers and other such contract people to service the other personnel, there is about 1462 people at the site. This is in addition to the normal compliment of about 500 site employees normally there (spread out over 3 shifts a day, 7 days a week).

The list does not include significant help by people off site, such as the NRC, National Laboratories, Hanford, Sandia, Oak Ridge, etc.
