This refers to the inspection conducted by T. J. Donat of this office on May 31, 1979, and June 1, 1979, of activities authorized by NRC Construction Permit No. CPPR-72 for the Sequoyah Unit 1 facility, and to the discussion of our findings held with W. E. Andrews at the conclusion of the inspection.

Areas examined during the inspection and our findings are discussed in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no items of noncompliance were disclosed.
