Gentlemen:

This refers to the inspection conducted by W. H. Miller, Jr., of this office on September 11-14, 1979, of activities authorized by NRC Construction Permit Nos. CPPR-83 and CPPR-84 for the McGuire facility, and to the discussion of our findings held with G. W. Grier at the conclusion of the inspection.

Areas examined during the inspection and our findings are discussed in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Three new unresolved items resulted from this inspection and are discussed in the enclosed report. These items will be examined during subsequent inspections.

Within the scope of this inspection, no items of noncompliance were disclosed.

During the inspection it was found that certain activities under your license appear to deviate from commitments to the Commission and have safety significance. These items are identified in the Notice of Deviation enclosed herewith as Appendix A. Please provide us in writing within 20 days of your receipt of this letter your comments including a description of corrective actions that have been or will be taken, corrective actions which will be taken to avoid further deviations, and the date corrective actions were or will be completed.


