The Nuclear Regulatory Commission's (NRC) Office of Investigations (OI) has closed the subject case regarding a Tennessee Valley Authority's contractor employee who was allegedly discriminated against for raising safety concerns at Watts Bar Nuclear Plant (WBN).

The NRC determined that there was insufficient evidence to substantiate the allegation that a contract laborer employed at WBN was discriminated for raising safety concerns.
