Short-Term Lessons Learned Recommendation

Dear Mr. Denton:

This letter supplements Florida Power Corporation's letters of October 17, 1979, November 17, 1979, January 11, 1980, February 6, 1980, and February 8, 1980, concerning the implementation of the NUREG-0578 Lessons Learned Recommendations and the Commission's January 2, 1980, Show Cause Order.

In our February 8, 1980, communication to you, Florida Power Corporation requested an extension of the February 15, 1980, implementation date for Item 2.1.4, Diverse Containment Isolation until March 15, 1980. This action was requested due to an identified potential unsafe operating condition and was consistent with the exemption granted on February 1, 1980, for Item 2.1.3.a, Direct Indication of PORV and Safety Valve Position.

We desire to further clarify the compensatory measures that were outlined in our February 8, 1980 submittal. Part 2 of our compensatory measures should read as follows:

- "2. A dedicated operator will remain in the Control Room at all times. In the case of an accident the dedicated operator's first duty is to close the eight (8) Containment Isolation Valves (that were not closed by Part 1 above) when the Reactor Coolant System Pressure is reduced to the RCS Pressure-Low Setpoint (1800 psig). Upon reaching the High Pressure Injection System Setpoint (1500 psig RCS Pressure), the operator will trip the Reactor Coolant Pumps."






