By the letter dated February 1, 2019, Community Health Association d/b/a Jackson General Hospital (Jackson General) requested written consent by the U.S. Nuclear Regulatory Commission (NRC) to a proposed plan where West Virginia University Hospitals, Inc. (WVUH) to become the sole corporate member of Jackson General Hospital. Jackson General will not change its legal name, doing business as name, or mailing address; nor will the membership substitution result in any immediate change to the officers, managers, or directors of the licensee.


Based on the above understandings and as more fully detailed in the enclosed NRC staff's Safety Evaluation Report, which documents the NRC staff's safety review of the request, and in accordance with 10 CFR 30.34, the NRC consents to the proposed transfer. We understand that the transfer will take place on November 16, 2018. Please note that you will need to notify us promptly, in writing, after the transaction has been finalized and include a signed copy of the sales agreement confirming completion of the transaction. If this planned sale has not been consummated within 30 days of the date of this letter, please notify us in writing. Future changes in the licensee's name, licensed use, licensed materials, licensed location, or persons responsible for licensed material, or other changes to the corporate structure require submission of a request to amend the license. NRC approval must be received prior to implementation of the proposed change.
