SUBJECT: TMI-2 EVENT REPORT BY METROPOLITAN EDISON

Karl Seyfrit asked me to determine whether an LER was submitted on the TMI-2 accident by Met Ed in regard to a deposition he was giving to the President's Commission. I had the request researched and it was reported from Region I that they had received an LER. Actually, the licensee did submit a 14 Day Followup Report dated April 11, 1979 (attached) which was not identified by him as an LER, but which was accepted as an LER in accordance with discussions between NRC and Met Ed. A discussion of subsequent reporting is given in the Met Ed letter report. The agreed-to reporting by Met Ed has been met. Please provide any clarification to the President's Commission that may be needed.

14 Day Follow-Up Report

On March 28, 1979, the Commission was notified by telephone of a nuclear incident at Three Mile Island Unit 2. Because of the complexity of the situation which existed and the onsite presence of the Commission during the reporting period, further details of the events leading to the incident and corrective action employed will be delayed until May 15. This report will contain information describing the event and preliminary short term corrective action up to April 30, 1979. This report will be updated by two additional monthly reports (May and June) which will be submitted on June 15 and July 15.

Following these first 3 monthly reports, quarterly reports will be submitted. The first of these quarterly reports will be submitted by October 15, 1979, and will include information compiled during the months of July, August, and September, 1979. These quarterly reports will be submitted every three months thereafter, and will be submitted prior to the 15th day of the month following the quarterly report period. These quarterly reports will include the similar type of information included in the monthly reports as well as those interim analysis results and interim evaluations concerning the event which have become available.

The quarterly reports discussed above will continue until a final report is issued. The final report will include a summary of Tech. Spec. violations which occurred during the transient. Also included will be a summary of the cause(s) of the incident as well as a sequence of events which occurred during the transient, and corrective actions (both short term and long term) which were taken as a result of the 3/28/79 incident. The reports discussed above will replace the reports required by Sections 6.9.1.6 (Monthly Operating Reports), 6.9.1.7, 6.9.1.8, 6.9.1.9 (Reportable Occurrences) and 6.9.2 (Special Reports) of the existing TMI-2 Technical Specifications. This method of updating was discussed with onsite Commission representatives on April 10, 1979.
