The Ownership Agreement, the Operating Agreement and the Substitute Power Agreement, all of which are referred to in the Application and are attached as exhibits thereto, will be executed by Middle South Energy, Inc. and South Mississippi EPA and with regard to the Substitute Power Agreement also by Mississippi Power & Light Company, in substantially the form attached to the Application. The Applicants intend to execute the Agreements within the next few weeks, at which time copies of the executed Agreements will be sent to the NRC as a supplement to the Application.


