This refers to the inspection conducted by P. J. Kellogg of this office on January 28-30, 1980 to verify the status of implementation of the Three Mile Island Action Plan items concerning management for operations and technical competence and to the discussion of our findings held with J. P. Calhoun at the conclusion of the inspection.

Areas examined during the inspection and our findings are discussed in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspectors.

Within the scope of this inspection, no items of noncompliance were disclosed.

In accordance with Section 2.790 of the NRC's "Rules of Practice", Part 2, Title 10, Code of Federal Regulations, a copy of this letter and the enclosed inspection report will be placed in the NRC's Public Document Room.
