NOTICE

On October 11, 1974, the Energy Reorganization Act (P.L. 93-438) was enacted. Pursuant to the Act the regulatory and licensing functions of the Atomic Energy Commission were transferred to the new Nuclear Regulatory Commission on January 19, 1975. (see Presidential Executive Order 11834, dated January 15, 1975).

The Act provides that all licensing proceedings pending before AEC shall continue without interruption under the auspices of the NRC, and all actions taken in those proceedings prior to the creation of NRC continue in effect.

The names "Atomic Safety and Licensing Board Panel" and "Atomic Safety and Licensing Board" continue unchanged.

The only change required by the enactment of the Act insofar as this proceeding is concerned is a change of the heading on all pleadings and orders filed herein after January 19, 1975, to read as follows:
