ATTCHMENT 1

1. Actions which will allow the operator to cope with various combinations of loss of instrumentation and control functions. This includes changes in (A) equipment and control systems to give clear indications of functions which are lost or unreliable; and (B) procedures and training to assure positive and safe manual response by the operator in the event that competent instruments are unavailable.

Response:

Florida Power Corporation commits to accomplish this item prior to the restart of Crystal River Unit 3.

 Verification of the effects of various combinations of loss of instrumentation and control functions by design review analysis and by test.

Response:

Florida Power Corporation commits to accomplish this item prior to the restart of Crystal River Unit 3.

3. Correction of electrical deficiencies which may allow the power operated relief valve and pressurizer spray valve to open on non-nuclear instrumentation power failures, such as, the event which occurred at Crystal River Unit 3 on February 26, 1980.

Florida Power Corporation commits to accomplish this item prior to the start of Crystal River Unit 3.
