This refers to the inspection conducted by Mr. F. Jape of this office on April 25-27, 1973, of the activities authorized by AEC Construction Permit No. CPPR-34 for the Oconee 2 facility, and to the discussions held with Mr. J. E. Smith of your staff at the conclusion of the inspection.

Areas examined during this inspection are as described in the enclosed inspection report No. 50-270/73-5. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with plant personnel, and observations by the inspector.

No violations or safety items were identified within the scope of this inspection.


