Dear Mr. Fidell:

This is in reply to your letter dated May 21, 1980, in which you requested, pursuant to the Freedom of Information Act, copies of all written communications between NRC personnel and any person in either House of Congress, since March 22, 1980, concerning the Three Mile Island facility. You will recall that you withdrew the second part of your request in your telephone conversation with Mr. Frank W. Karas of this office on June 5, 1980.

In response to your request, the documents listed in Appendix A are enclosed. Our search for documents subject to your request is continuing and you will be informed if any additional documents are identified. The charge for reproducing records at locations other than the NRC Public Document Room is ten cents (\$0.10) per page, as specified in 10 CFR 9.14(h); a copy of which is enclosed.
