2. Meeting Purpose and Summary

The purpose of this meeting was to determine the status of the implementation of the upgrade plan for the Oyster Creek Nuclear Generating Station Radiation Protection Program. This upgrade plan had originally been submitted by the licensee in the June 5, 1979 Enforcement Management meeting held at NRC Region I.

Licensee representatives presented an implementation schedule from the original plan which had been modified to illustrate the status of each of the items. Region I management noted that the licensee appeared to be adhering to the implementation schedule presented in the previous meeting.

Regional management presented the following comments and observations:

- -- There appeared to be a need for additional administrative assistance to the Station Manager. This additional assistance would permit the Station Manager to get more involved in day to day station activities.
- -- There was a need for a formal in-plant health physics audit program.
- -- A radiation protection training/retraining program should be established.
- -- Radiation protection involvement in Emergency Planning appeared limited.
- -- A Health Physicist should be placed on the Plant Operations Review Committee (PORC).
- -- There was a definite need for improved ALARA and respirator protection programs.

Licensee representatives concurred and indicated action would be taken to address the above areas.

The licensee representatives requested an additional meeting, which would be held in approximately one month, to further update Region I on the status of the upgrade items. Region I concurred on this request.
