The U. S. Nuclear Regulatory Commission (the Commission) has issued Amendment No. 7 to the Facility Operating License No. NPF-3, issued to the Toledo Edison Company and the Cleveland Electric Illuminating Company, for operation of the Davis-Besse Nuclear Power Station, Unit No. 1 (the facility) located in Ottawa County, Ohio. The amendment is effective as of its date of issuance.

This license is amended by making the appropriate changes as listed to the technical specifications on pages 3/4 3-7 and 3/4 3-13. This license is further amended by changing license conditions 2.C.(2), 2.C.(3)(k) and 2.C.(3)(l) and removing license conditions 2.C.(3)(m) and 2.C.(3)(q) of Facility Operating License No. NPF-3. License conditions 2.C.(3)(m), and 2.C.(3)(q) have been fully satisfied.

The amendment complies with the standards and requirements of the Atomic Energy Act of 1954, as amended (the Act), and the Commission's rules and regulations. The Commission has made appropriate findings as required by the Act and the Commission's rules and regulations in 10 CFR
