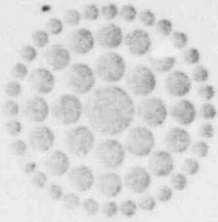

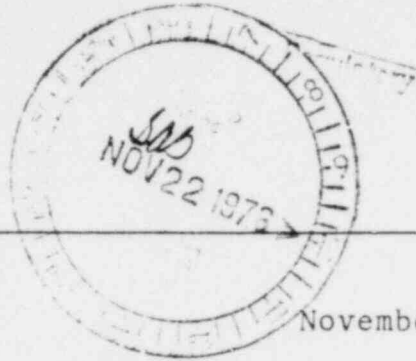

Dear Mr. Engle:

As per our phone conversations on November 17, 1976, Florida Power Corporation hereby commits to upgrade the level indication for the BWST to meet the following conditions:

- (1) Provide two level indications via of independent channels.
- (2) Power independent channels by separate power supplies.
- (3) Qualify equipment both environmentally and seismically.
- (4) Meet IEEE-279 to the extent practicable.
- (5) Test system after modifications are complete.
- (6) Provide details of modification to NRC as soon as possible with schedule for installation of modification.
