Gentlemen:

Haddam Neck Plant Millstone Nuclear Power Station, Unit Nos. 1 and 2 Emergency Planning

In Reference (1), Connecticut Yankee Atomic Power Company (CYAPCO) and Northeast Nuclear Energy Company (NNECO) were requested to provide additional information on the Haddam Neck Plant and Millstone Nuclear Power Station Site Emergency Plans relative to the criteria in NUREG-0654. Both Site Emergency Plans had been revised in accordance with the criteria specified in Reference (2) and docketed on January 1, 1980, prior to the publication of the "proposed" guidance of NUREG-0654.

The attached submittal was prepared to provide the Staff with CYAPCO's and NNECO's responses to NUREG-0654 criteria. These responses will be incorporated into the next revision of the Site Emergency Plans, which will be submitted to the NRC in the near future to allow for review and implementation by January, 1981. Implementation dates for specific items are given in the responses.

Also attached is one (1) copy of the State of Connecticut Radiological Emergency Response Plan. Copies of the State of Connecticut Radiological Emergency Response Plan were provided to both NRR and the Office of State Programs in 1978. Attachments 1 and 2, Plant Procedures for CYAPCO and NNECO respectively, contain material which would constitute an unwarranted invasion of privacy if disclosed to the public. CYAPCO and NNECO request that these attachments be withheld from public disclosure as provided under NRC Rules and Regulations in 10CFR2.790. The attached material is formatted to facilitate exclusion of proprietary material from the Public Document Room. The procedures are not being issued to the NRC as cr.trolled copy documents and, hence, will not be updated.
