 - Complete the perforated plate investigation by studying: (1) the effect of water nozzle direction and diameter on the erd of complete bypass (EOCB), varying water temperature (12-50C) and levation above plate (scaled to reactor): and (2) propagation effects on EOCB due to jet penetration of a single hole.
 - Complete the Vertical Countercurrent flow work by installing additional instrumentation and assessing the current data base for local condensation rates. Additional instruments should include heated pitot tubes, pressure taps, differential pressure cells and impedance probes.
 - Complete the Horizontal Concurrent Flow work by investigating the onset of bridging and condensation shocks.
