SUBJECT: ANTICIPATED MEDIA INTEREST IN NRC INVESTIGATION

On November 7 at 10:30 a.m., a member of the South Carolina legislature met with media representatives concerning construction practices at the Summer site. The issues discussed parallel those currently under investigation by Region II. Areas of indicated concern include undersize welds on socket welds on safety-related systems (Schedule 150 piping) and use of carbon steel brushes in weld preparation on safety-related stainless steel piping. Full range and depth of comments made to the media are unknown at this time. The Region II investigation onsite commenced October 19 and is continuing.

Media interest in the Columbia, South Carolina area is expected due to ongoing utility rate hike hearings involving licensee. The State of South Carolina has been notified. No decision has yet been reached by the licensee regarding a press release on this subject. Region II will respond to media inquiries with a statement that the investigation is ongoing.

Region II (Atlanta) received notification of this occurrence by telephone from a member of South Carolina Utility Reform Coalition at 11:30 a.m. on November 7, 1979.
