At 7:00 a.m. on October 23, 1979, the Daniel International Corporation Personnel trailer received a bomb threat call. The voice sounded like a young girl. She stated, "A bomb will go off in your building." She then hung up.

The trailer building was evacuated and a search completed. No bomb was found. No site evacuation was conducted.

The Sheriff of Cowley County, Kansas City FBI and AIR were notified. The AIR and offices of Commissioner Hendrie and Kennedy were notified by telephone on October 23, 1979.

No press release was made or planned by the licensee or NRC.

The site construction progress is currently 37%. There is no SNM on site.

This Preliminary Notification is issued for information only and no further action by IE is anticipated. Region IV, Arlington, Texas, received notification of this occurrence by telephone from the KG&E Site Security Officer at 7:15 a.m. on October 23, 1979.
